KG hereby confirms that the transport contractual liability of the policyholder as contractor is insured in accordance with the insurance conditions of the SPEDITIONS-, LOGISTIK- und LAGER-VERSICHERUNGS-SCHEIN-Plus (SLVS-Plus®), which fulfils the minimum requirements of § 7 a Güterkraftverkehrsgesetz (GüKG).

Liability is insured in accordance with the following provisions:

- German Freight Forwarders' Standard Terms and Conditions (ADSp), as amended;
- Standard market terms and conditions for the forwarding, warehousing and transport industry in Europe;
- German statutory provisions, in particular §§ 407 et seq. HGB;
- The further freight contract liability agreed with the principals within the framework of the provided legal liability corridor according to § 449 Para. 2 No. 1 HGB to up to 40 special drawing rights (SDR) per kg of the gross weight of the consignment;
- Convention on the Contract for the International Carriage of Goods by Road (CMR);
- Budapest Convention on the Contract for the Carriage of Goods by Inland Waterway (CMNI);
- Convention concerning International Carriage by Rail and Uniform Rules concerning the Contract for International Carriage of Goods by Rail (Appendix B - COTIF/CIM, current version);
- SMGS;
- 1999 Montreal Convention and Warsaw Convention (WA);
- Hague Rules; Hague-Visby Rules; Hamburg Rules;
- National legal provisions for the transport industry in the states within the territorial scope of this insurance contract.



The insurance benefit is limited for damage to goods and consequential damage to goods as follows:

** For damage to goods and consequential damage to goods in the case of ordered storage, the general limit of indemnity per claim does not apply. Only the limit per loss event is decisive here.		

#### Heavy cargo module

Coverage for liability arising from heavy lift contracts.

The insurance benefit is limited to EUR 2.500.000 per claim and EUR 5.000.000 per loss event.

#### Customs and excise duties module

Cover for liability arising from the execution of customs clearances of any kind (customs orders).

The insurance benefit is limited to EUR 150.000 per customs offence and EUR 750.000 per insurance year.
